Debt and Redemption in the Blues

This volume explores concepts of freedom and bondage in the blues and argues that this genre of music explicitly calls for a reckoning while expressing faith in a secular justice to come. Placing blues music within its historical context of the post-Reconstruction South, Jim Crow America, and the civil rights era, Julia Simon finds a deep symbolism in the lyrical representations of romantic and sexual betrayal. The blues calls out and indicts the tangled web of deceit and entrapment constraining the physical, socioeconomic, and political movement of African Americans. Surveying blues music from the 1920s to the early twenty-first century, Simon's analyses focus on economic relations, such as sharecropping, house contract sales, debt peonage, criminal surety, and convict lease. She demonstrates how the music reflects this exploitative economic history and how it is shaped by commodification under racialized capitalism. As Simon assesses the lyrics, technique, and styles of a wide range of blues musicians, including Bessie Smith, Blind Lemon Jefferson, Big Bill Broonzy, Muddy Waters, B. B. King, Albert Collins, and Kirk Fletcher, she argues forcefully that the call for racial justice is at the heart of the blues. A highly sophisticated interpretation of the blues tradition steeped in musicology, social history, and critical-cultural hermeneutics, *Debt and Redemption* not only clarifies blues as an aesthetic tradition but, more importantly, proves that it advances a theory of social and economic development and change.

Fictions of Consent

In *Fictions of Consent* Urvashi Chakravarty excavates the ideologies of slavery that took root in early modern England in the period that preceded the development of an organized trade in enslaved persons. Despite the persistent fiction that England was innocent of racialized slavery, Chakravarty argues that we must hold early modern England—and its narratives of exceptional and essential freedom—to account for the frameworks of slavery that it paradoxically but strategically engendered. Slavery was not a foreign or faraway phenomenon, she demonstrates; rather, the ideologies of slavery were seeded in the quotidian spaces of English life and in the everyday contexts of England's service society, from the family to the household, in the theater and, especially, the grammar school classroom, where the legacies of classical slavery and race were inherited and negotiated. The English conscripted the Roman freedman's figurative "stain of slavery" to register an immutable sign of bondage and to secure slavery to epidermal difference, even as early modern frameworks of "volitional service" provided the strategies for later fictions of "happy slavery" in the Atlantic world. Early modern texts presage the heritability of slavery in early America, reveal the embeddedness of slavery within the family, and illuminate the ways in which bloodlines of descent underwrite the racialized futures of enslavement. *Fictions of Consent* intervenes in a number of areas including early modern literary and cultural studies, premodern critical race studies, the reception of classical antiquity, and the histories of law, education, and labor to uncover the conceptual genealogies of slavery and servitude and to reveal the everyday sites where the foundations of racialized slavery were laid. Although early modern England claimed to have "too pure an Air for Slaves to breathe in," Chakravarty reveals slavery was a quintessentially English phenomenon.

White Land, Black Labor

The society of the postbellum South was built upon two interweaving but ultimately irreconcilable systems: a racist caste system and an economic class system. The caste system was supposed to assure that all whites would be equals above the underclass of black laborers. But the class system that emerged in the years after the war placed lower-class whites in the same economic position as the emancipated slaves -- a situation totally at odds with prevailing white ideology. In *White Land, Black Labor*, Charles Flynn examines the interplay of the caste and class systems of Reconstruction Georgia, revealing how the efforts of both the planters and poorer whites to retain blacks in a position of subservience assured that in this state -- as in the South as a whole -- there would be little significant economic progress until well into the next century. The caste faith of the white Georgians encouraged landowning employers to seek increased exploitation rather than economic growth; at the same time, it motivated landless whites to focus their energies on the greater subordination of black laborers rather than on achieving equality with wealthier whites. Despite the facade of southern caste faith, the constitutional amendments adopted during Reconstruction assured that blacks could not legally be treated as a separate laboring class. As a result, the measures employed by the planters to increase their control over the black laborers applied to a growing number of landless whites as well. With blacks more free and whites more oppressed than the prevailing social ideology deemed appropriate, the distinction between the system of class division among whites and the caste barrier that separated blacks and whites began to fracture -- leading to political dissent in the nineteenth century and setting the stage for the demagogue politicians of the twentieth century.

American Slavery, American Imperialism

Slavery casts a long shadow over American history; despite the cataclysmic changes of the Civil War and emancipation, the United States carried antebellum notions of slavery into its imperial expansion at the turn of the twentieth-century. African American, Chinese and other immigrant labourers were exploited in the name of domestic economic development, and overseas, local populations were made into colonial subjects of America. How did the U.S. deal with the paradox of presenting itself as a global power which abhorred slavery, while at the same time failing to deal with forced labour at home? Catherine Armstrong argues that this was done with rhetorical manoeuvres around the definition of slavery. Drawing primarily on representations of slavery in American print culture, this study charts how definitions and depictions of slavery both changed and stayed the same as the nation became a prominent actor on the world stage. In doing so, Armstrong challenges the idea that slavery is a merely historical problem, and shows its relevance in the contemporary world.

Servants and Servitude in Colonial America

The dispossessed people of Colonial America included thousands of servants who either voluntarily or involuntarily ended up serving as agricultural, domestic, skilled, and unskilled laborers in the northern, middle, and southern British American colonies as well as British Caribbean colonies. Thousands of people arrived in the British-American colonies as indentured servants, transported felons, and kidnapped children forced into bound labor. Others already in America, such as Indians, freedmen, and poor whites, placed themselves into the service of others for food, clothing, shelter, and security; poverty in colonial America was relentless, and servitude was the voluntary and involuntary means by which the poor adapted, or tried to adapt, to miserable conditions. From the 1600s to the 1700s, Blacks, Indians, Europeans, Englishmen, children, and adults alike were indentured, apprenticed, transported as felons, kidnapped, or served as redemptioners. Though servitude was more multiracial and multicultural than slavery, involving people from numerous racial and ethnic backgrounds, far fewer books have been written about it. This fascinating new study of servitude in colonial America provides the first complete overview of the varied lives of the dispossessed in 17th- and 18th-century America, examining colonial American servitude in all of its forms.

The Shadow of Slavery

Whether peonage in the South grew out of slavery, a natural and perhaps unavoidable interlude between bondage and freedom, or whether employers distorted laws and customs to create debt servitude, most Southerners quietly accepted peonage. To the employer it was a way to control laborers; to the peon it was a bewildering system that could not be escaped without risk of imprisonment, beating, or death. Pete Daniel's book is about this largely ignored form of twentieth-century slavery. It is in part "the record of an American failure, the inability of federal, state, and local law-enforcement officers to

end peonage." In a series of case studies and histories, Daniel re-creates the neglected and frightening world of peonage, demanding, "If a form of slavery yet exists in the United States, as so much evidence suggests, then the relevant questions are why, and by whose irresponsibility?" Peonage grew out of labor settlements following emancipation, when employers forbade croppers to leave plantations because of debt (often less than \$30). At the turn of the century the federal government acknowledged that the "labyrinth of local customs and laws" binding men in debt was peonage. They outlawed debt servitude and slowly moved against it, but with no large success. Disappearing witnesses and acquitted employers characterized the cases that did go to court. Daniel holds that peonage persists for many reasons: the corruption and apathy of law-enforcement, racist traditions in the South, and the impotence of the Justice Department in prosecuting this violation of federal law. He draws extensively on complaints and trial transcripts from the peonage records of the Justice Department.

The Worlds of Unfree Labour

The proliferation of literature on the various forms of human exploitation before the nineteenth century provides the *raison d'être* for this seminal collection of essays. Indentured Servitude

Hundreds of thousands of British and Irish men, women, and children crossed the Atlantic during the seventeenth century as indentured servants. Many had agreed to serve for four years, but large numbers had been trafficked or "spirited away" or were sent forcibly by government agencies as criminals, political rebels, or destitute vagrants. In *Indentured Servitude* Anna Suranyi provides new insight into the lives of these people. The British government, Suranyi argues, profited by supplying labour for the colonies, removing unwanted populations, and reducing incarceration costs within Britain. In addition, it was believed that indigents, especially destitute children, benefited morally from being placed in indenture. Capitalist entrepreneurs who were influential at the highest levels of government made their fortunes from Atlantic trade in goods, indentured servants, and slaves, and their participation in the servant trade contributed to the commercialization of criminal justice. Suranyi breaks new ground in showing how indentured servitude was challenged: once in the colonies, indentured servants adapted resourcefully to their circumstances and rebelled against unfair conditions and abuse by suing their masters, by running away, or through outright revolt. Emerging ideas about race and citizenship

led to vehement public debate about the conditions of indentured servants and the ethics of indenture itself, prompting legislation that aimed to curb the worst excesses while slavery continued to expand unchecked.

From Jim Crow to Civil Rights

A Rift in the Clouds

A Rift in the Clouds chronicles the efforts of three white southern federal judges to protect the civil rights of African Americans at the beginning of the twentieth century, when few in the American legal community were willing to do so. Jacob Treiber of Arkansas, Emory Speer of Georgia, and Thomas Goode Jones of Alabama challenged the Supreme Court's reading of the Reconstruction amendments that were passed in an attempt to make disfranchised and exploited African Americans equal citizens of the United States. These unpopular white southerners, two of whom who had served in the Confederate Army and had themselves helped to bring Reconstruction to an end in their states, asserted that the amendments not only established black equality, but authorized the government to protect blacks. Although their rulings won few immediate gains for blacks and were overturned by the Supreme Court, their legal arguments would be resurrected, and meet with greater success, over half a century later during the civil rights movement.

An Old Creed for the New South

An Old Creed for the New South: Proslavery Ideology and Historiography, 1865–1918 details the slavery debate from the Civil War through World War I. Award-winning historian John David Smith argues that African American slavery remained a salient metaphor for how Americans interpreted contemporary race relations decades after the Civil War. Smith draws extensively on postwar articles, books, diaries, manuscripts, newspapers, and speeches to counter the belief that debates over slavery ended with emancipation. After the Civil War, Americans in both the North and the South continued to debate slavery's merits as a labor, legal, and educational system and as a mode of racial control. The study details how white Southerners continued to tout slavery as beneficial for both races long after Confederate defeat. During Reconstruction and after Redemption, Southerners continued to refine proslavery ideas while subjecting blacks to new legal, extralegal, and social controls. An Old Creed for the New South links pre- and post-Civil War racial thought, showing historical continuity, and treats the Black Codes and the Jim Crow laws in new ways, connecting these important racial and legal themes to intellectual and social history. Although many blacks and some whites denounced slavery as the source of the contemporary "Negro problem," most whites, including late nineteenth-century historians, championed a "new" proslavery argument. The study also traces how historian Ulrich B. Phillips and Progressive Era scholars looked at slavery as a golden age of American race relations and shows how a broad range of African Americans, including Booker T. Washington and W. E. B. Du Bois, responded to the proslavery argument. Such ideas, Smith posits, provided a powerful racial creed for the New South. This examination of black slavery in the American public mind—which includes the arguments of former slaves, slaveholders, Freedmen's Bureau agents, novelists, and essayists—demonstrates that proslavery ideology dominated racial thought among white southerners, and most white northerners, in the five decades following the Civil War.

Lyman Trumbull and the Second Founding of the United States

The Civil War and Reconstruction periods in United States history are widely viewed as a "second founding" of the nation—one that sought to bring the American regime into better alignment with the aspirations articulated at the first founding. Among the figures involved in shaping this new start for the American republic, Lyman Trumbull played an instrumental role. As the chairman of the influential

Senate Judiciary Committee, Trumbull advanced the most important legislation of both the Civil War and Reconstruction, including the First and Second Confiscation Acts, the Habeas Corpus Act of 1863, the 1866 Freedmen's Bureau Act, and the Military Reconstruction Acts. Most significantly, he was the principal author and driver of the Thirteenth Amendment, which abolished slavery permanently throughout the United States. On the basis of the Thirteenth Amendment, he also authored the Civil Rights Act of 1866, the nation's first civil rights law, which protected the fundamental rights of all Americans, regardless of race, color, or previous condition of servitude. Despite being arguably the greatest legislative architect of America's second founding, Trumbull later turned his back on the Reconstruction that he helped initiate. Worried that Reconstruction was going too far and lasting too long, he eventually embraced a rigid and uncompromising view of states' rights, rejecting his own previous defense of the national government's ultimate power and responsibility to secure the privileges and immunities of US citizenship. Paul Rego's study of Trumbull's political and constitutional thought is a much-needed exploration of this key figure in Civil War and Reconstruction history. Like the framers of the first founding, Trumbull was complex and contradictory—a symbol of both the nation's rebirth and its lost promise, as responsible for the period's disappointments as he was for its triumphs. A Treatise on the American Law of Easements and Servitudes

In the late 1860s the U.S. federal government initiated the most abrupt transition from slavery to citizenship in the Americas. The transformation, of course, did not stick, but it did permanently alter the terms of American citizenship and initiated a century long struggle over the place of African Americans in the American polity. Southern Progressives, crucial in this account, were faced with a significant ideological challenge: how to reconcile their liberal principles with their commitments to racial hierarchy. The ideological work performed by Southern Progressives was instrumental to the establishment of white supremacist institutions in the heart of a putatively liberal democracy and illuminate how combinations of liberal and illiberal principles have affected the history of American political thought. In this work, Marek Steedman demonstrates how Southern Progressives combined commitments to liberal, even democratic, politics with equally strong commitments to the maintenance of racial hierarchy. He shows that there are systematic features of the traditions of liberal and republican thought, on the one hand, and ideologies of race, on the other, that facilitate their combination. Jim Crow Citizenship relates familiar developments in American state-building, legal development, and political

thought to race, thus showing how race intertwines with these developments, often shaping them in decisive fashion.

Jim Crow Citizenship

More than forty years after *Brown v. Board of Education* put an end to segregation of the races by law, current debates about affirmative action, multiculturalism, and racial hate speech reveal persistent uncertainty about the meaning of race in American culture and the role of law in guaranteeing racial equality. *Race, Law and Culture* takes the continuing controversy about race as an invitation to revisit *Brown*, and *Brown* as a lens through which to view that controversy. As they move through the Federalist era, they draw subtly perceptive character sketches not only of the great figures--Washington and Jefferson, Talleyrand and Napoleon Bonaparte--but also of lesser ones, such as George Hammond, Britain's frustrated minister to the United States, James McHenry, Adams's hapless Secretary of War, the pre-Chief Justice version of John Marshall, and others. They weave these lively profiles into an analysis of the central controversies of the day, turning such intricate issues as the public debt into fascinating depictions of opposing political strategies and contending economic philosophies. Each dispute bears in some way on the broader story of the emerging nation. The authors show, for instance, the consequences the fight over Hamilton's financial system had for the locating of the nation's permanent capital, and how it widened an ideological gulf between Hamilton and the Virginians, Madison and Jefferson, that became unbridgeable. The statesmen of the founding generation, the authors believe, did "a surprising number of things right." But Elkins and McKittrick also describe some things that went resoundingly wrong: the hopelessly underfinanced effort to construct a capital city on the Potomac (New York, they argue, would have been a far more logical choice than Washington), and prosecutions under the Alien and Sedition Acts which turned into a comic nightmare. No detail is left out, or left uninteresting, as their account continues through the Adams presidency, the XYZ affair, the naval Quasi-War with France, and the desperate Federalist maneuvers in 1800, first to prevent the reelection of Adams and then to nullify the election of Jefferson. The Age of Federalism is the fruit of many years of discussion and thought, in which deep scholarship is matched only by the lucid distinction of its prose. With it, Stanley Elkins and Eric McKittrick have produced the definitive study, long awaited by historians, of the early national era.
