The congressional agenda, Frances Lee contends, includes many issues about which liberals and conservatives generally agree. Even over these matters, though, Democratic and Republican sen-

ators tend to fight with each other. What explains this discord? Beyond Ideology argues that many partisan battles are rooted in competition for power rather than disagreement over the rightful role of government. The first book to systematically distinguish Senate disputes centering on ideological questions from the large proportion of them that do not, this volume foregrounds the role of power struggle in partisan conflict. Presidential leadership, for example, inherently polarizes legislators who can influence public opinion of the president and his party by how they handle his agenda. Senators also exploit good government measures and floor debate to embarrass opponents and burnish their own party's image—even when the issues involved are broadly supported or low-stakes. Moreover, Lee contends, the congressional agenda itself amplifies conflict by increasingly focusing on issues that reliably differentiate the parties. With the new president pledging to stem the tide of partisan polarization, Beyond Ideology provides a timely taxonomy of exactly what stands in his way.

Principles of Government

Notable Early Treatise on the Principles of American Government. A revised version of Nathaniel Chipman's Sketches of the Principles of Government (1793), this early treatise on the underlying principles of American government addresses civil laws and obligations, the social state, rights of property, sovereignty and political power. An important early contribution to American constitutional law, it is also interesting for its Federalist perspective on the evolutions of political institutions from Washington to Jackson. Nathaniel Chipman [1752-1843] was a leading Vermont Federalist who was instrumental in that state's admission to the Union. He became Vermont's chief Justice and went on to represent Vermont in the U.S. Senate. He was also one of America's first significant legal writers. One of his books, the Reports and Dissertations (1793) is included in Warren's list of "the four general works on the Common Law... [of] permanent value in American Legal Literature." The Invention of the United States Senate

The invention of the United States Senate was the most complicated and confounding achievement of the Constitutional Convention. Although much has been written on various aspects of Senate history, this is the first book to examine and link the three central components of the Senate's creation: the theoretical models and institutional precedents leading up to the Constitutional Convention; the work of the Constitutional Convention on both the composition and powers of the Senate; and the initial institutionalization of the Senate from ratification through the early years of Congress. The authors show how theoretical principles of a properly constructed Senate interacted with political interests and power politics in the multidimensional struggle to construct the Senate, before, during, and after the convention.

Congressional Government

"For almost 30 years, political scientists have believed that the Senate would be less affected by partisan polarization due to the existence of a handful of moderate senators who would act as power brokers between the two sides, yet year after year we see partisan gridlock. Life in the Middle argues that the belief in the powerful, pivotal moderate neglects their electoral circumstances, and overestimates their legislative power. Indeed, not all senators are elected under equal circumstances where the modern centrist has to balance between two conflicting constituencies like Susan Collins in Maine, or represents a state where the opposition outnumbers their base like Joe Manchin in West Virginia. Using data compiled from the Congressional Record, the book examines the legislative behaviour of moderates and find that they seldom amend legislation to their preferences, rarely speak on the record, and often lose on final votes. Using unique interview data with 19 legislative directors and six retired centrist senators, it also finds that the behind the scenes conversations mirror the on-stage behaviour where centrists are not influential or viewed as pivotal by party leaders. Furthermore, moderates reported less satisfaction with legislative outcomes than their peers. Life in the Middle suggests that law-making needs to be re-evaluated as being much more variable and less reliant on the work of moderates and more on party leaders. Indeed, the mainstream concerns about polarization and its negative effects of increased gridlock and ideological legislation may be true"--

How Our Laws are Made

sion. "The Federalist", as it was previously known, was constructed by American statesman Alexander Hamilton, and was intended to catalyse the ratification of the United States Constitution. Hamilton recruited fellow statesmen James Madison Jr., and John Jay to write papers for the compendium, and the three are known as some of the Founding Fathers of the United States. Alexander Hamilton (c. 1755–1804) was an American lawyer, journalist and highly influential government official. He also served as a Senior Officer in the Army between 1799-1800 and founded the Federalist Party, the system that governed the nation's finances. His contributions to the Constitution and leadership made a significant and lasting impact on the early development of the nation of the United States.

Our American Government

Under the Constitution of the United States, those with political ambitions who aspire to serve in the federal government must be at least twenty-five to qualify for membership in the House of Representatives, thirty to run for the Senate, and thirty-five to become president. What is the justification for these age thresholds, and is it time to consider changing them? The American Commonwealth

Once known as the greatest deliberative body in the world, it now has a reputation as a partisan, dysfunctional chamber. What happened to the house that forged American history's great compromises? In this groundbreaking work, a distinguished journalist and an eminent historian provide an insider's history of the United States Senate. Richard A. Baker, historian emeritus of the Senate, and Neil MacNeil, former chief congressional correspondent for Time magazine, integrate nearly a century of combined experience on Capitol Hill with deep research and state-of-the-art scholarship. They explore the Senate's historical evolution with one eye on persistent structural pressures and the other on recent transformations. Here, for example, are the Senate's struggles with the presidency--from George Washington's first, disastrous visit to the chamber on August 22, 1789, through now-forgotten conflicts with Presidents Garfield and Cleveland, to current war powers disputes. The authors also explore the Senate's potent investigative power, and show how it began with an inquiry into John Brown's raid on Harpers Ferry in 1859. It took flight with committees on the conduct of the Civil War, Reconstruction, and World War II; and it gained a high profile with Joseph McCarthy's rampage against communism, Estes Kefauver's organized-crime hearings (the first to be broadcast), and its Watergate investigation. Within the book are surprises as well. For example, the office of majority leader first acquired real power in 1952--not with Lyndon Johnson, but with Republican Robert Taft. Johnson accelerated the trend, tampering with the sacred principle of seniority in order to control issues such as committee assignments. Rampant filibustering, the authors find, was the ironic result of the passage of 1960s civil rights legislation. No longer stigmatized as a white-supremacist tool, its use became routine, especially as the Senate became more partisan in the 1970s. Thoughtful and incisive, The American Senate: An Insider's History transforms our understanding of Congress's upper house.
