#### The Role of Civil Society in Africa's Quest for Democratization

Much has been written about how civil society challenges authoritarian governments and helps lead the way to democratization. These studies show that neoliberal economic policies have harmed many sectors of society, weakening the state and undermining clientelistic relationships that previously provided material benefits to middle- and low-income citizens, who are then motivated to organize coalitions to work for greater social justice and equality. Recognizing this important role played by civil society organizations, Jon Shefner goes further and analyzes the variegated nature of the interests represented in these coalitions, arguing that the differences among civil society actors are at least as important as their similarities in explaining how they function and what success, or lack thereof, they have experienced. Through an ethnographic examination extending over a decade, Shefner tells the story of how a poor community on the urban fringe of Guadalajara mobilized through an organization called the Unión de Colonos Independientes (UCI) to work for economic improvement with the support of Jesuits inspired by liberation theology. Yet Mexico's successful formal democratic transition, won with the elections in 2000, was followed by the dissolution of the coalition. Neither political access for the urban poor, nor their material well-being, has increased with democratization. The unity and even the concept of civil society has thus turned out to be an illusion.

# The Illusion of Civil Society

Since the emergence of the dissident "parallel polis" in Eastern Europe, civil society has become a "new superpower," influencing democratic transformations, human rights, and international co-operation; co-designing economic trends, security and defense; reshaping the information society; and generating new ideas on the environment, health, and the "good life." #### International Democracy and the West

#### Global Civil Society in Action

#### The Democratic Implications of Civil Society in China

The development of civil society has varied greatly across the former Soviet Union. The Baltic states have achieved a high level of integration with the West and European Union membership, while some

regions in Russia lag far behind. Now for the first time there is a comparative study of civil society and democratization across post-Soviet national borders. Acknowledging the enormous variation throughout the region, the book offers unique data on developments in Russia, Estonia, Latvia and Lithuania. #### Civil Society and the State in Left-Led Latin America

This book examines the relationship between civil society and human security in the Indian state of Meghalaya, part of the region known as Northeast India. Civil society has been revived over the last two decades and is now one of the key concepts in development, politics, and international aid. The concept has gained particular significance as part of attempts to analyse and instigate grassroots democratisation through widespread political participation. This is seen as enabling a broader range of issues to be politicised and made a part of political agendas at the local, national, and global levels. However there are few studies that examine the constraints on civil society at the local level, even in contexts where civil society may appear to be active and vibrant. Those studies that do exist tend to focus on the constraints coming from the state, overlooking the constraints that come from within civil society itself. During the same period human security has gained prominence as a challenge to state-centric conceptions of security and as an alternative approach to development by focusing on the security and insecurity of groups and individuals. The concept has been taken up by international organisations, development agencies, and bilateral donors as a more effective way to understand the difficulties people face in their everyday lives that go beyond conventional categories and indicators. In order for those experiencing insecurity to identify and contest the causes of insecurity, participation in civil society is necessary.

In this timely, informative edited volume, major Iranian scholars and civic actors address some of the most pressing questions about Iranian civil society and the process of democratization in Iran. They describe the role of Iranian civil society in the process of transition to democracy in Iran and offer insight about the enduring legacy of previous social and political movements—starting with the Constitutional Revolution of 1906— in the struggle for democracy in Iran. Each contributor looks at different aspects of Iranian civil society to address the complex nature of the political order in Iran and the possibilities for secularization and democratization of the Iranian government.
