South Africa, the colonial powers and African Defence

For imperialists, the concept of guardian is specifically to the armed forces that kept watch on the frontiers and in the heartlands of imperial territories. Large parts of Asia and Africa, and the islands of the Pacific and the Caribbean were imperial possessions. The book explains

the political and military pressures which drove successive French governments to widen the scope of French military operations in Algeria between 1954 and 1958. It also explores gender issues and African colonial armies.

The Oxford Handbook of the Cold War

The 20th Century has been one of enduring, rapid and fundamental social and political change. In Southern Africa, innumerable wars, rebellions, uprisings and protests have marked the integration, disintegration and then reintegration of both society and subcontinent during this period. The century started with a brief but total war. Less than ten years later victorious Britain brought the conquered Boer republics, and the Cape and Natal colonies, together into the Union of South Africa. And the military of this early creation served not only in all of the major wars of the twentieth century, but also in a number of regional struggles: rebellion on the part of Afrikaner nationalists, industrial unrest fanned by syndicalists, and uprisings conducted chiefly but not exclusively by disenfranchised black South Africans. The century ended as it started, with a war. But this was a limited war, a flashpoint of the Cold War, which embraced more than just the subcontinent and lasted a long, twenty-three years. The first of its kind, A Military History of Modern South Africa provides an overview of South African military history from 1899 to 2000. Focusing on the campaigns and battles, it also brings discussion on the evolving military policy and the development of the South African military as an institution into a single volume.

Decolonization in Africa

A Military History of Modern South Africa

This personal account of one officer's experiences in the South African War is based upon the letters, diaries, signals, and over 1000 photographs of Lieutenant Malcolm Riall. A signals officer with the West Yorkshires, Riall was just 20 years old when he embarked for active service in 1899.

Disconsolate Empires

This work is a study of civil-military relations in the Republic of South Africa while Pieter Willem Botha was prime minister (1978-89). The author's controversial thesis is that Prime Minister Botha, recognizing that his country had reached the historical juncture when it needed to establish a new political order encompassing all of its diverse peoples, moved effectively to prepare the ground for fundamental constitutional change. What was needed above all were stabilization measures to assure the support of the white population for reform. Botha used the South African defence force as his primary instrument. By 1989, Professor Roherty maintains, a striking degree of stabilization had been achieved within the country and throughout South Africa, and the groundwork for epochal change had been prepared. The author makes use of exclusive interviews with South Africans from the political, military, intelligence, corporate, and academic worlds.

World War I in Africa

This is the first attempt to bring together diverse scholars, using different lenses, to study South Africa's Border War. As a book, it is critical in approach, provides deeper reflection, and focuses specifically on the SADF experience of the war. The result is a more complex picture of the war's dynamics and its legacies. Although South Africa is a vastly different country today, the study of the Border War opens a range of questions, also relevant to contemporary deployments such as in Lesotho (1998) and the Central African Republic (2013). It includes the debate on participation in foreign conflicts; on the deployment, design and preparation of appropriate, modern armed forces and their use as foreign policy instruments in far off theatres; on military planning; and, as the historical controversies regarding the battles at Cuito Cuanavale and Bangui illustrate, on the interface between foreign campaigning and domestic politics.

Matabeleland

In 1880 the continent of Africa was largely unexplored by Europeans. Less than thirty years later, only Liberia and Ethiopia remained unconquered by them. The rest - 10 million square miles with 110 million bewildered new subjects - had been carved up by five European powers (and one extraordinary individual) in the name of Commerce, Christianity, 'Civilization' and Conquest. The Scramble for Africa is the first full-scale study of that extraordinary episode in history.

African History: A Very Short Introduction

An examination of how peacekeeping is woven into national, regional and international politics in Africa, and its consequences.

Africa

Looking at decolonization in the conditional tense, this volume teases out the complex and uncertain ends of British and French empire in Africa during the period of 'late colonial shift' after 1945. Rather than view decolonization as an inevitable process, the contributors together explore the crucial historical moments in which change was negotiated, compromises were made, and debates were staged. Three core themes guide the analysis: development, contingency and entanglement. The chapters consider the ways in which decolonization was governed and moderated by concerns about development and profit. A complementary focus on contingency allows deeper consideration of how colonial powers planned for 'colonial futures', and how divergent voices greeted the end of empire. Thinking about entanglements likewise stresses both the connections that existed between the British and French empires in Africa, and those that endured beyond the formal transfer of power.

Boer War

Remember the global peace dividend - the budget surpluses that were supposed to result from the raising of the Iron Curtain and the end of the arms race? As war-torn societies in the Middle East, Latin America, and parts of Africa found peace and began building democratic societies, governments were

supposed to use the money they once spent on the military to better meet basic human needs. But has it happened?

State Security in South Africa

This book examines a largely neglected phenomenon in the field of international relations--the concept of the isolated state. Deon Geldenhuys begins by discussing how he measures both voluntary and enforced international isolation by, among other things, membership of international organizations, official visits and international censure. He then presents a number of case studies of self-isolation. The remainder of the study is devoted to an analysis of the enforced isolation of Taiwan, Israel, Chile and South Africa. Using a wealth of statistical material, he demonstrates their varying degrees of isolation in the diplomatic, military, economic and socio-cultural arenas of the international community.

In Different Times

The decolonization of Namibia was delayed from 1966 to 1989—the period of the war of independence—pitting the Namibian nationalists against the South African minority-ruled regime. This book describes the diplomatic, economic and military campaigns of the Namibian and South African belligerents and draws a comparison with several other decolonization wars. Using data from parliamentary debates, the aftermath is examined of the Namibian war and the newly independent nation. The book provides a basis for further investigation of the decolonization process.

The Scramble For Africa

Originally published in 1968, this volume traces the history and growth of Apartheid in South Africa. The acts which enforced Apartheid – the Group Areas Act, Population and Registration Act are given in full. The book also includes documents which reflected reaction to these measures: Parliamentary debates, newspaper reports and policy statements by the leading political parties and religious denominations. The documents are headed by a full historical and analytical introduction.

African Peacekeeping

The Lion and the Springbok presents an account of the dynamics and divergences of the 'uneasy special relationship' of Britain and South Africa. From the bruising experience of the South African War (1899-1902) to South Africa's withdrawal from the Commonwealth in 1961, the authors chart this relationship in all its political, economic, cultural and geostrategic aspects. All the major disputes are discussed including the struggle for the High Commission Territories, the crisis over Seretse Khama's marriage and the transfer of the Simon's Town naval base. These issues trace, for the most part, a continuing deterioration in relations, as Afrikaner nationalist identity hardened and South African politics slid into the extremes of apartheid. The perceptions each side had of the other after 1948 are examined through representations in the media, and an epilogue considers the reasons for the return of the 'New South Africa' to the Commonwealth in 1994.
