Special education teachers and parents of children with special education needs are often unaware of the statutory rights under the Individual with Disabilities Education Act ("IDEA"), and how to enforce them. On the flip side they sometimes do not realize how broad the law is, or how and what they must do to meet the laws requirements. The author starts with the premise that one of the hardest aspects of studying this law is find a friendly, easy way into the statutes. Further, heavily digested court cases offer examples of what can go wrong if the proper procedures are not followed. For example, the first case present in the book is one where the parents forced the school district to pay for their child to attend a fancy private school, as well as pay for meals and transportation to that school. Believe in My Child with Special Needs!

To any professional concerned with exceptional children, it would be the greatest understatement to say that the courts and legislatures have had a tremendous impact on the field of special education. Especially in the last decade, a flood of litigation filed to develop and define the right to education of previously unserved handicapped children has left no special education teacher, school adminis trator, nurse, educational psychologist, or pediatrician unaffected-either be cause these professionals are daily called upon to help children, or because they may come forward as witnesses on behalf of children who are the subjects of special education meetings, individualized education programs, placement hear ings, or judicial proceedings. Thus, for these people, questions regarding a student's legal rights are immediate and pervasive. This book developed out of the need to provide nonlegal professionals with a lawyer's view of the huge body of court cases and federal laws and regulations that affect their practice as well as their students and clients. An introductory chapter provides the historical basis of the current interface between law and special education. The Education for All Handicapped Children Act of 1975 and Sec tion 504 of the Rehabilitation Act of 1973, and their regulations promulgated in 1977, are the major national laws in the field ~nd are therefore described in Chapters 2 and 3.

Meeting Families Where They Are

By introducing a human rights perspective to special education, this book detaches the concept of special needs from its origin in handicap and roots it instead in human rights. Also implied in this view is the notion of the teacher or policymaker as an advocate for children's rights.

Special Education Law

The topic of parent participation in existing literature centers around what school personnel think and do, but there has been very little research looking at how parents experience special education. Parents hold a unique role in special education because of the parental right to participate under the Individuals with Disabilities Education Act. Additionally, there is an apparent gap as to why the parent rights, mandated under IDEA, have been insufficient to protect students from patterns long recognized as problematic. The current study examines two research questions: 1) How do parents from historically marginalized identities perceive their role in their child's special education? 2) Why hasn't parent inclusion served as a better preventative to disproportionality? To address these questions, I employ phenomenological practices with a mixed methodological approach. I established a new Conceptual Framework for Parents Navigating Special Education to critically construct tools and examine web-based surveys (n=39) and virtual interviews (n=8). Findings are outlined using a systemic organization which refers to three points in time parents and children experience the special education system: before beginning special education, when entering special education, and when they are within the special education system. Themes and results are shared, which focus on the parent experience, beliefs, and perspectives of parents navigating their child's special education. Major findings include: 1) how parents conceptualize their pre-system views and beliefs regarding their child's education (e.g., before entering the system), 2) observations and situations from the parents' perspectives that caused them to realize their child needed services in school (e.g., entering the system), 3) what parents do

when their child is receiving services within the special education system (e.g., within the system). Recommendations and implications for policy, practice, and research are discussed in the final chapter.

Procreation, Parenthood, and Educational Rights

Children and young people have a fundamental right to be heard and taken seriously about matters affecting them. They have the same general human rights as adults, but also possess specific rights that recognise their special needs and potential. He finds the "signature" formula for the myth--the divine hero who slays the serpent or overcomes adversaries--occurs in the same linguistic form in a wide range of sources and over millennia, including Old and Middle Iranian holy books, Greek epic, Celtic and Germanic sagas, down to Armenian oral folk epic of the last century. Watkins argues that this formula is the vehicle for the central theme of a proto-text, and a central part of the symbolic culture of speakers of the Proto-Indo-European language: the relation of humans to their universe, the values and expectations of their society. Therefore, he further argues, poetry was a social necessity for Indo- European society, where the poet could confer on patrons what they and their culture valued above all else: "imperishable fame."

Trading with the Market Wizards

There is nothing new in Wall Street. There can't be because speculation is as old as the hills. Whatever happens in the stock market today has happened before and will happen again. The desire for constant action irrespective of underlying conditions is responsible for many losses in Wall Street even among professionals. I never lose my temper over the stock market. I never argue the tape. Getting sore at the market doesn't get you anywhere. They say you can never go poor taking profits. No, you don't. But neither do you grow rich taking a four-point profit in a bull market. Where I should have made twenty thousand I made two thousand. That was what my conservatism did for me. Remember that stocks are never too high for you to begin buying or too low to begin selling. A man may see straight and clearly and yet become impatient or doubtful when the market takes its time about doing as he figured it must do. That is why so many men in Wall Street...nevertheless lose money. The market does not beat them. They beat themselves, because though they have brains they cannot sit tight. After spending many years in Wall Street and after making and losing millions of dollars I want to tell you this: It never was my thinking that made the big money for me. It always was the sitting. Got that? My sitting tight!Losing money is the least of my troubles. A loss never bothers me after I take it...But being wrong-not taking the loss-that is what does the damage to the pocketbook and to the soul. Prices, like everything else, move along the line of least resistance. They will do whatever comes easiest. The speculator's chief enemies are always boring from within. It is inseparable from human nature to hope and to fear. In speculation when the market goes against you hope that every day will be the last day-and you lose more than you should had you not listened to hope-the same ally that is so potent a success-bringer to empire builders and pioneers, big and little. And when the market goes your way you become fearful that the next day will take away your profit, and you get out-too soon. Fear keeps you from making as much money as you ought to. The successful trader has to fight these two deep-seated instincts...Instead of hoping he must fear; instead of fearing he must hope.
