# William J. Seymour and the Origins of Global Pentecostalism

In 1906, William J. Seymour (1870–1922) preached Pentecostal revival at the Azusa Street mission in Los Angeles. From these and other humble origins the movement has blossomed to 631 million people around the world. Gastón Espinosa provides new insight into the life and ministry of Seymour, the Azusa Street revival, and Seymour's influence on global Pentecostal origins. After defining key terms and concepts, he surveys the changing interpretations of Seymour over the past 100 years, critically engages them in a biography, and then provides an unparalleled collection of primary sources, all in a single volume. He pays particular attention to race relations, Seymour's paradigmatic global influence from 1906 to 1912, and the break between Seymour and Charles Parham, another founder of Pentecostalism. Espinosa's fragmentation thesis argues that the Pentecostal propensity to invoke direct unmediated experiences with the Holy Spirit empowers ordinary people to break the bottle of denominationalism and to rapidly indigenize and spread their message. The 104 primary sources include all of Seymour's extant writings in full and without alteration and some of Parham's theological, social, and racial writings, which help explain why the two parted company. To capture the revival's diversity and global influence, this book includes Black, Latino, Swedish, and Irish testimonies, along with those of missionaries and leaders who spread Seymour's vision of Pentecostalism globally.

# Political Pentecostalism

The last decade has witnessed fundamental shifts in the relationship between religion and politics. In this light, religious symbols, motifs, justifications, and practices are increasingly noticeable in political discourses, as well as agendas, particularly in the Global South, with Pentecostal Christians standing out as salient actors. Performative practices enacted in political contexts such as the anointing of state authorities, prophecies, warfare prayers, etc. have drawn the attention of numerous scholars worldwide. The four surveys contained in this volume account for these developments in Africa, Asia, and Latin America, and synoptically engage with the following question: Can any meaningful nexus connecting multiple and apparently isolated nodes of Pentecostal engagement in the political sphere around the globe be identified? # Protestantism and State Formation in Postrevolutionary Oaxaca

"The Strangers in Our Midst tells the story of how American evangelicals have responded to refugees and immigrants - ranging from the Cuban refugee influx in the 1960s, to the Southeast Asian refugees in the 1980s, to undocumented immigrants from Latin America in the 1990s and 2000s. Evangelical Christians have been a pillar of US immigration and refugee policy since the end of World War II in two key ways: by acting as refugee sponsors and by offering legalization assistance to undocumented immigrants. They developed an elaborate evangelical theology of hospitality, which emphasized scriptural commands to "welcome the stranger." Initially, evangelicals did not distinguish between legal immigrants and refugees and "illegal," undocumented immigrants. However, a growing anti-immigrant consensus in American society at large and their political alignment with the Republican Party caused them to shed their welcoming approach to immigrants in the 1990s. Evangelicals were now divided in their stances on immigration, as conservative evangelicals viewed only legal immigrants as deserving of their aid, while progressive evangelicals-led by their Latinx coreligionists-emphasized the need for Christians to help all immigrants. In the twenty-first century, a group of Latinx evangelical leaders resurrected and reshaped the evangelical theology of hospitality in an effort to turn the tide in the evangelical debate on immigration. The results are mixed: Unprecedented numbers of evangelicals favor a pathway to citizenship for undocumented immigrants. Yet as the 2016 presidential election showed, this preference had no impact on their political choices"--

This book explores how intra-party politics affects government formation and termination in parliamentary systems, where the norm is the formation of coalition governments. The authors look beyond party cohesion and discipline in parliamentary democracies to take a broader view, assuming a diversity of preferences among party members and then exploring the incentives that give rise to coordinated party behaviour at the electoral, legislative and executive levels. This book explores why political parties negotiate such agreements, and argues that coalition agreements are important control devices that allow coalition parties to keep their partners in line. The authors show that their use varies with the preference configuration in cabinet and the allocation of ministerial portfolios. First, they posit that parties will only negotiate policy issues in a coalition agreement when they disagree on these issues and when they are important to all partners. Second, since controlling a ministry provides parties with important information and policy-making advantages, parties use agreements to constrain their partners particularly when they control the ministry in charge of a policy area. Finally, they argue that coalition agreements only work as effective control devices if coalition parties settle controversial issues in these contracts. The COALITIONAGREE Dataset is used to evaluate the expectations set out in the

book; the dataset maps the content of 229 coalition agreements that were negotiated by 189 parties between 1945 and 2015 in 24 Western and Eastern European countries. The results show that coalition parties systematically use agreements to control their partners when policy issues are divisive and salient and when they are confronted with a hostile minister. These agreements only effectively contain conflicts, however, when parties negotiate a compromise on precisely the issues that divide them.
