The Philosophical Imagination

The Philosophical Imagination brings together several of Richard Moran's essays, ranging over a remarkable variety of topics in philosophy of mind and action, aesthetics, and moral psychology. A theme connecting several of the essays is the different ways our capacity for imagination is drawn on in our responsiveness to art, to literature, to the lives of other persons, and in the practice of philosophy itself. Topics explored here include our emotional responses to mimetic works of art, the nature of metaphor as a vehicle of thought and in the work of rhetoric, and the understanding of the concept of beauty, as that is developed in contrasting ways in the work of Immanuel Kant and Marcel Proust. Several of the essays respond to the work of recent and contemporary philosophers such as Bernard Williams, Stanley Cavell, Harry Frankfurt, and Iris Murdoch, in the context of such themes as the philosophical problem of 'other minds', love and practical reason, the legacy of Sartrean existentialism, and the role of history in the disciplinary self-understanding of philosophy. The final group of essays focuses on questions about self-knowledge and the importance of the first-person perspective, developing ideas from Moran's influential book *Authority and Estrangement* (Princeton 2001). Topics discussed here include the nature of a person's 'practical knowledge' of her own action, the concept of the mental and the differences between self-understanding and the understanding of others, and the ambiguous role of narrative as a form of self-understanding. Throughout there is an attempt to draw out the connections between topics that are often discussed in isolation from each other, and to pursue them in the context of the recognizable human situations and questions which

ground them. The essays are written in a vivid, humane, and accessible style which should attract a broad readership, both inside and outside the academic discipline of philosophy.

Recreative Minds

Recreative Minds develops a philosophical theory of imagination that draws upon recent theories and results in psychology. Ideas about how we read the minds of others have put the concept of imagination firmly back on the agenda for philosophy and psychology. Currie and Ravenscroft present a theory of what they call imaginative projection; they show how it fits into a philosophically motivated picture of the mind and of mental states, and how it illuminates and is illuminated by recent developments in cognitive psychology. They argue that we need to recognize a category of desire-in-imagination, and that supposition and fantasy should be classed as forms of imagination. They accommodate some of the peculiarities of perceptual forms of imagining such as visual and motor imagery, and suggest that they are important for mind-reading. They argue for a novel view about the relations between imagination and pretence, and suggest that imagining can be, but need not be, the cause of pretending. They show how the theory accommodates but goes beyond the idea of mental simulation, and argue that the contrast between simulation and theory is neither exclusive nor exhaustive. They argue that we can understand certain developmental and psychiatric disorders as arising from faulty imagination. Throughout, they link their discussion to the uses of imagination in our encounters with art, and they conclude with a chapter on responses to tragedy. The final chapter also offers a theory of the emotions that suggests that these states have much in common with perceptual states. Currie and Ravenscroft offer a lucid exploration of a fascinating subject, for readers in philosophy, psychology, and aesthetics.

Simulation Theory

Theory of Mind (ToM) is the term used for our ability to predict and explain the behaviour of ourselves and others. Accounts of this theory have so far fallen into two competing types: Simulation Theory and 'Theory Theory'. In contrast with Theory Theory, Simulation Theory argues that we predict behaviour not by employing a model of people, but by replicating others' thoughts and feelings. This book presents a novel defence of Simulation Theory, reviewing the major challenges against it and positing the theory as the most effective method for exploring how we know each other and ourselves. Drawing on key research in the field, chapters reopen the debates surrounding Theory of Mind and cover a variety of topics including schizophrenia with implications for experimental social psychology. In the past, one of the greatest criticisms against Simulation Theory is that it cannot explain systematic error in Theory of Mind. This book explores the rapidly developing heuristics and biases programme, pioneered by Kahneman and Tversky, to suggest that a novel bias mismatch defence available to Simulation Theory explains these systematic errors. Simulation Theory: A psychological and philosophical consideration will appeal to a range of researchers and academics, including psychologists from the fields of cognitive, social and developmental psychology, as well as philosophers, psychotherapists and practitioners looking for further research on Theory of Mind. The book will also be of relevance to those interested in autism, since it offers a new approach to Theory of Mind which explains central symptoms in autistic subjects.

The Self and Self-Knowledge

David Hume and the Problem of Other Minds

The problem of other minds has widely been considered as a special problem within the debate about scepticism. If one cannot be sure that there is a world existing independent ly of one's mind, how can we be sure that there are minds - minds which we cannot even experience the way we experience material objects? This book shows, through a detailed examination of David Hume's *A Treatise of Human Nature*, that these concerns are unfounded. By focusing on Hume's discussion of sympathy - the ability to connect with the mental contents of other persons - Anik Waldow demonstrates that belief in other minds can be justified by the same means as belief in material objects. The book thus not only provides the first large-scale treatment of the function of the belief in other minds within the *Treatise*, thereby adding a new dimension to Hume's realism, but also serves as an invaluable guide to the complexity of the problem of other minds and its various responses in contemporary debate.

Physics of the Human Mind

Minding Dogs

While the past decade has seen a surge of research regarding canine cognition, this newfound interest has not caught the attention of many philosophers. Studies pertaining to dog minds have been pouring out of canine cognition labs all over the world, but they remain relatively ensconced within the scientific, sociological, and anthropological communities, and very little philosophical thought on dog cognition exists. Philosophers certainly have not shied away from theorizing about the nature of nonhuman animal cognition generally. Theories range from Cartesian disavowal of all nonhuman intelligence to arguments that even fish have complex minds and therefore humans should not eat them. Serious philosophical considerations about dogs and their relationship to humans, however, remain incredibly rare. Even less common, if not entirely nonexistent, is a critical examination of the question "What are dogs thinking?" and what asking and attempting to answer this question reveals, not so much about dogs, but about us. With *Minding Dogs* Michele Merritt attempts to fill two significant gaps in the philosophy of animal cognition. First, she adds to the growing discussion on canine cognition, which has been overlooked until recently and requires more consideration. Second, she takes seriously our dynamic collaborations with our canine friends as crucial to understanding both their minds and our own.

The Aesthetic of Play

Language Mind and Logic

This is a collection of eleven original essays in analytical philosophy by British and American philosophers, centring on the connection between mind and language. Two themes predominate: how it is that thoughts and sentences can represent the world; and what having a thought - a belief, for instance - involves. Developing from these themes are the questions: what does having a belief require of the believer, and of the way he or she relates to the environment? In particular, does having a belief require speaking a language? The volume concludes the informal series stemming from the meetings sponsored by the Thyssen Foundation. It will interest analytical philosophers, students doing courses in philosophy of mind within the analytical tradition and philosophically interested researchers in cognitive psychology.

Mind, Values, and Metaphysics

There are three themed parts to this book: values, ethics and emotions in the first part, epistemology, perception and consciousness in the second part and philosophy of mind and philosophy of language in the third part. Papers in this volume provide links between emotions and values and explore dependency between language, meanings and concepts and topics such as the liar's paradox, reference and metaphor are examined. This book is the second of a two-volume set that originates in papers presented to Professor Kevin Mulligan, covering the subjects that he contributed to during his career. This volume opens with a paper by Moya, who proposes that there is an asymmetrical relation between the possibility of choice and moral responsibility. The first part of this volume ends with a description of foolishness as insensitivity to the values of knowledge, by Engel. Marconi's article makes three negative claims about relative truth and Sundholm notes shortcomings of the English language for epistemology, amongst other papers. This section ends with a discussion of the term 'subjective character' by Nida-Rümelin, who finds it misleading. The third part of this volume contains papers exploring topics such as the mind-body problem, whether theory of mind is based on simulation or theory and Künné shows that the most common analyses of the so-called 'Liar' paradox are wanting. At the end of this section, Rizzi introduces syntactic cartography and illustrates its use in scope-discourse semantics. This second volume contains twenty nine chapters, written by both high profile and upcoming researchers from across Europe, North America and North Africa. The first volume of this set has two main themes: metaphysics, especially truth-making and the notion of explanation and the second theme is the history of philosophy with an emphasis on Austrian philosophy.

Reflection on arguments used in that book led the author to make the distinctions which have been indicated by the phrases 'in imagination', 'with imagination', and the term 'supposal'. This book is mainly a philosophical study of the leading concepts.

The Language of Thought in Late Medieval Philosophy

This book is a collection of essays in honor of Paul Ziff written by his colleagues, students, and friends. Many of the authors address topics that Ziff has discussed in his writings: understanding, rules and regularities, proper names, the feelings of machines, expression, and aesthetic experience. Paul Ziff began his professional career as an artist, went on to study painting with J. M. Hanson at Cornell, and then studied for the Ph. D. in philosophy, also at Cornell, with Max Black. Over the next three decades he produced a series of remarkable papers in philosophy of art, culminating in 1984 with the publication of *Antiaesthetics: An Appreciation of the Cow with the Subtle Nose*. In 1960 he published *Semantic Analysis*, his masterwork in philosophy of language. Throughout his career he made important contributions to philosophy of mind in such papers as "The Simplicity of Other Minds" (1965) and "About Behaviourism" (1958). In addition to his work in these areas, his lectures at Harvard on philosophy of religion are an underground classic; and throughout his career he has continued to make art and to search for the meaning of life in the properties of prime numbers. Although his interests are wide and deep, questions about language, art, and mind have dominated his philosophical work, and it is problems in these areas that provide the topics of most of the essays in this volume.

The Conceptual Mind

Imagination, Philosophy and the Arts is the first comprehensive collection of papers by philosophers examining the nature of imagination and its role in understanding and making art. Imagination is a central concept in aesthetics with close ties to issues in the philosophy of mind and the philosophy of language, yet it has not received the kind of sustained, critical attention it deserves. This collection of

seventeen brand new essays critically examines just how and in what form the notion of imagination illuminates fundamental problems in the philosophy of art.

Language, Mind, and Art

The nature of the mind and of consciousness; the reality of freedom; the concept of agency and the relation of language to the mental are all basic perennial philosophical issues. They are some of the topics pursued in these original essays by leading thinkers in the field of the contemporary philosophy of mind and action. The essays are based on the lectures given in The Royal Institute of Philosophy's annual lecture series for 2001-2002.

Imagination, Philosophy and the Arts

This volume presents a selection of the philosophical essays which Richard Rorty wrote during the first decade of his career, and complements four previous volumes of his papers published by Cambridge University Press. In this long neglected body of work, which many leading philosophers still consider to be his best, Rorty develops his views on the nature and scope of philosophy in a manner which supplements and elucidates his definitive statement on these matters in *Philosophy and the Mirror of Nature*. He also develops his groundbreaking version of eliminative materialism, a label first coined to describe his position, and sets out original views on various central topics in the philosophy of language, concerning private language, indeterminacy, and verificationism. A substantial introduction examines Rorty's philosophical development from 1961 to 1972. The volume completes our understanding of Rorty's intellectual trajectory and offers lucid statements of positions which retain their relevance to current debates.

Minds and Persons

This edited volume examines the relationship between collective intentionality and inferential theories of meaning. The book consists of three main sections. The first part contains essays demonstrating how researchers working on inferentialism and collective intentionality can learn from one another. The essays in the second part examine the dimensions along which philosophical and empirical research on human reasoning and collective intentionality can benefit from more cross-pollination. The final part consists of essays that offer a closer examination of themes from inferentialism and collective intentionality that arise in the work of Wilfrid Sellars. *Groups, Norms and Practices* provides a template for continuing an interdisciplinary program in philosophy and the sciences that aims to deepen our understanding of human rationality, language use, and sociality.

Mind, Language, and Metaphilosophy

Mind, Meaning, and Reality contains fifteen philosophical papers by D. H. Mellor, including a new defence of 'success semantics', and an introduction arguing that metaphysics can and need only be justified by doing it and not by a 'meta-metaphysics', which it needs no more than physics needs metaphysics. The papers are grouped into three parts. Part I is about how the ways we are disposed to act fix both what we believe and what we use language to mean. Part II is about what there is: the reality of dispositions; what makes beliefs and sentences true; why there is only one universe; and how social groups, and other things composed of parts, are related to the people and other things that constitute them. Part III is about time, and includes discussions of twentieth century developments in the philosophy of time; why Kant was right about tense, even though he was wrong about time; why forward time travel is trivial and backward time travel impossible; and what gives time its direction.

Subject Guide to Books in Print

This now-classic work challenges what Ryle calls philosophy's "official theory," the Cartesian "myth" of the separation of mind and matter. Ryle's linguistic analysis remaps the conceptual geography of mind, not so much solving traditional philosophical problems as dissolving them into the mere consequences of misguided language. His plain language and essentially simple purpose put him in the tradition of Locke, Berkeley, Mill, and Russell - philosophers whose best work, like Ryle's, has become a part of our general literature.
