Shared racial and cultural experiences and the collective memory of those experiences play important roles in determining the responses of African Americans to issues of crime and violence. By examining American history through the prism of African American experience, this volume provides a framework for understanding contemporary issues regarding crime and justice, including the much-discussed

gap between how blacks and whites perceive the fairness of the criminal justice system. Following a thesis offered by W.E.B. Questionable police practices, like stop-and-frisk, combined with media sensationalism, cemented the belief that black youth were the primary cause for concern. Even before the War on Crime, the stakes were clear: race would continue to be the crucial determinant in American notions of crime and delinquency, and black youths condemned with a stigma of criminality would continue to confront the overwhelming power of the state.

In the Shadow of the Gallows

From Puritan Execution Day rituals to gangsta rap, the black criminal has been an enduring presence in American culture. To understand why, Jeannine Marie DeLombard insists, we must set aside the lenses of pathology and persecution and instead view the African American felon from the far more revealing perspectives of publicity and personhood. When the Supreme Court declared in *Dred Scott* that African Americans have "no rights which the white man was bound to respect," it overlooked the right to due process, which ensured that black offenders—even slaves—appeared as persons in the eyes of the law. In the familiar account of African Americans' historical shift "from plantation to prison," we have forgotten how, for a century before the Civil War, state punishment affirmed black political membership in the breach, while a thriving popular crime literature provided early America's best-known models of individual black selfhood. Race, Gender, and Punishment

Mary Bosworth and Jeanne Flavin bring together twelve original essays by prominent scholars to examine not only the discrimination that is evident, but also the structural and cultural forces that have influenced and continue to perpetuate the current situation. Contributors point to four major factors

that have impacted public sentiment and criminal justice policy : colonialism, slavery, immigration, and globalization. In doing so they reveal how practices of punishment not only need particular ideas about race to exist, but they also legitimate them. The essays unearth troubling evidence that testifies to America's brutally racist past, and to White America's continued fear of and suspicion about racial and ethnic minorities. The legacy of slavery on punishment is considered, but also subjects that have received far less attention such as how colonizers' notions of cultural superiority shaped penal practices, the criminalization of reproductive rights, the link between citizenship and punishment, and the global export of crime control strategies.

Slave Laws in Virginia

The five essays in *Slave Laws in Virginia* explore two centuries of the ever-changing relationship between a major slave society and the laws that guided it. The topics covered are diverse, including the African judicial background of African American slaves, Thomas Jefferson's relationship with the laws of slavery, the capital punishment of slaves, nineteenth-century penal transportation of slaves from Virginia as related to the interstate slave trade and the changing market for slaves, and Virginia's experience with its own fugitive slave laws. Through the history of one large extended family of ex-slaves, Philip J. Schwarz's conclusion examines how the law shaped the interaction between former slaves and masters after emancipation. Instead of relying on a static view of these two centuries, the author focuses on the diverse and changing ways that lawmakers and law enforcers responded to slaves' behavior and to whites' perceptions of and assumptions about that behavior.

Roots of Disorder

Every white southerner understood what keeping African Americans "down" meant and what it did not mean. It did not mean going to court; it did not mean relying on the law. It meant vigilante violence and lynching. Looking at Vicksburg, Mississippi, *Roots of Disorder* traces the origins of these terrible attitudes to the day-to-day operations of local courts. Manfred Berg traces the history of lynching in America from the colonial era to the present. Berg focuses on lynching as extralegal communal punishment performed by "ordinary" people. He confronts racially fragmented historical memory and legacies of popular justice to help the reader make better sense of lynching as part of American history.

Race, Labor, and Punishment in the New South

For Emile Durkheim, writing in the nineteenth-century, punishment was simply understood as a clear response to the criminal behavior a society experiences. Today's penal institutions challenge such a simple understanding. Inseparably linked with many aspects of society, they are profoundly shaped by the traumatic events and changes a society undergoes. Nowhere is this clearer than in the American South. Georgia embraced the concept of the penitentiary as a form of social control earlier than most of its southern neighbors. Its penal code of 1816 replaced or curtailed such traditional punishments as whipping, the pillory, fines, or death. Georgia's control over felony convicts effectively began in 1817, when the state prison at Milledgeville accepted its first convict. Martha A. Myers finds that Georgia also led the region in embracing the convict lease system as an alternative to incarceration. In *Race, Labor, and Punishment in the New South*, she examines the social, political, and economic forces that shaped punishment over a seventy-year period. Between 1870 and 1940, Georgia's system of punishment shifted from capital and corporal punishment to hard labor in the penitentiary, then to the convict lease system, then to county-run chain gangs, and then back to incarceration in prison. This book forges a connection between these dramatic shifts and analyzes three facets of punishment for black and white men: rates of admission to the penitentiary, the harshness of sentences, and the ease with which felons achieved release from the penitentiary. Her findings challenge the conventional notion that hard

times invariably prompt harsh punishment. In uncovering the complex link between social change and southern punishment, Myers reveals the poverty of current theories of criminal punishment.

Race, Crime, and Punishment

The death penalty arouses our passions as does few other issues. Some view taking another person's life as just and reasonable punishment while others see it as an inhumane and barbaric act. But the intensity of feeling that capital punishment provokes often obscures its long and varied history in this country. Now, for the first time, we have a comprehensive history of the death penalty in the United States. Law professor Stuart Banner tells the story of how, over four centuries, dramatic changes have taken place in the ways capital punishment has been administered and experienced. In the seventeenth and eighteenth centuries, the penalty was standard for a laundry list of crimes--from adultery to murder, from arson to stealing horses. Hangings were public events, staged before audiences numbering in the thousands, attended by women and men, young and old, black and white alike. Early on, the gruesome spectacle had explicitly religious purposes--an event replete with sermons, confessions, and last minute penitence--to promote the salvation of both the condemned and the crowd. Through the nineteenth century, the execution became desacralized, increasingly secular and private, in response to changing mores. In the twentieth and twenty-first centuries, ironically, as it has become a quiet, sanitary, technological procedure, the death penalty is as divisive as ever. By recreating what it was like to be the condemned, the executioner, and the spectator, Banner moves beyond the debates, to give us an unprecedented understanding of capital punishment's many meanings. As nearly four thousand inmates are now on death row, and almost one hundred are currently being executed each year, the furious debate is unlikely to diminish. Much of the current reassessment of race, culture, and criminal justice in the nineteenth-century South has been based on intensive community studies. Drawing on previously untapped sources, the nine original papers collected here represent some of the best new work on how racial justice can be shaped by the particulars of time and place. This edition also features excerpts from several other writings by Darrow on law, crime and punishment. An important Afterword by Carol Heises, an attorney and activist involved with prisoners on Cook County Jail's Death Row focuses on Darrow's views on capital punishment. Plus, a Foreword from Penelope Rosemont.

Crime & Criminals

Liberty's Prisoners examines how changing attitudes about work, freedom, property, and family shaped the creation of the penitentiary system in the United States. The first penitentiary was founded in Philadelphia in 1790, a period of great optimism and turmoil in the Revolution's wake. Those who were previously dependents with no legal standing—women, enslaved people, and indentured servants—increasingly claimed their own right to life, liberty, and happiness. A diverse cast of women and men, including immigrants, African Americans, and the Irish and Anglo-American poor, struggled to make a living. Vagrancy laws were used to crack down on those who visibly challenged longstanding social hierarchies while criminal convictions carried severe sentences for even the most trivial property crimes. The penitentiary was designed to reestablish order, both behind its walls and in society at large, but the promise of reformatory incarceration failed from its earliest years. Within this system, women served a vital function, and *Liberty's Prisoners* is the first book to bring to life the experience of African American, immigrant, and poor white women imprisoned in early America. Always a minority of prisoners, women provided domestic labor within the institution and served as model inmates, more likely to submit to the authority of guards, inspectors, and reformers. White men, the primary targets of reformatory incarceration, challenged authorities at every turn while African American men were increasingly segregated and denied access to reform. *Liberty's Prisoners* chronicles how the penitentiary, though initially designed as an alternative to corporal punishment for the most egregious of offenders, quickly became a repository for those who attempted to lay claim to the new nation's promise of liberty.

Liberty's Prisoners

Why did some offenses in the South end in mob lynchings while similar crimes led to legal executions? Why did still other cases have nonlethal outcomes? In this well-researched and timely book, Margaret Vandiver explores the complex relationship between these two forms of lethal punishment, challenging the assumption that executions consistently grew out of-and replaced-lynchings. Vandiver begins by examining the incidence of these practices in three culturally and geographically distinct southern

regions. In rural northwest Tennessee, lynchings outnumbered legal executions by eleven to one and many African Americans were lynched for racial caste offenses rather than for actual crimes. In contrast, in Shelby County, which included the growing city of Memphis, more men were legally executed than lynched. Marion County, Florida, demonstrated a firmly entrenched tradition of lynching for sexual assault that ended in the early 1930s with three legal death sentences in quick succession. With a critical eye to issues of location, circumstance, history, and race, Vandiver considers the ways that legal and extralegal processes imitated, influenced, and differed from each other. A series of case studies demonstrates a parallel between mock trials that were held by lynch mobs and legal trials that were rushed through the courts and followed by quick executions. Tying her research to contemporary debates over the death penalty, Vandiver argues that modern death sentences, like lynchings of the past, continue to be influenced by factors of race and place, and sentencing is comparably erratic.

Lost at Sea

"We returned to our loved ones, but we were never the same again. Most were markedly changed. Young boys had become mature older men, aged beyond their years. All because of those days in the sea." For five days near the end of the Second World War, the USS Indianapolis disappeared from the map. After being hit by two torpedoes from a Japanese submarine, the warship sank within twelve minutes: 900 men out of a crew of 1200 managed to jump free. But by the time they were found, all that time later, the survivors had plummeted to just 316 men. The story of how that happened, and how the few that remained of her crew were eventually rescued from the mid-Pacific, have become one of the most enduring - and notorious - of wartime sea stories. The United States lost hundreds of ships during the course of World War II, from the deadly explosion of the USS Arizona during the attack on Pearl Harbor to the sinking of John F. Kennedy's PT-109, a patrol boat with a crew of less than 15. However, few of the ships lost in the Pacific suffered a fate as gripping or tragic as the sinking of the heavy cruiser USS Indianapolis on July 30, 1945. The USS Indianapolis had been launched nearly 15 years earlier, and it had already survived kamikaze attacks while fighting the Japanese. In July 1945, the cruiser and its crew of nearly 1,200 delivered parts for the first atomic bomb to an air base at Tinian, but due to a chain of events and miscommunication, the cruiser veered into the path of a Japanese submarine shortly after midnight on July 30. Torpedo attacks sank the ship within 15 minutes of the encounter, and about 300 men went down with the ship, but unfortunately, the trials and tribulations were just starting for the survivors. After the call to abandon ship and distress signals were sent out, nearly 900 men found themselves in the water, but the Navy remained unaware of the fate of the Indianapolis, so the survivors would end up spending over 4 days adrift at sea. Those who didn't drown had to deal with the effects of dehydration, starvation, and exposure, but while those conditions were terrible enough, the most notorious aspect of the story was the presence of sharks, and the seemingly random nature in which they attacked the sailors. The sailors could never be sure if a gruesome death was coming at any instant, especially at night, and while it's unclear how many men were actually eaten by sharks, salvage efforts eventually found the remains of nearly 60 bodies that indicated they were bitten. By the time rescue efforts were completed, just 300 men were saved, and the fallout over the episode was intense. To this day, the sinking of the USS Indianapolis is controversial, and historians continue to debate who shouldered the most blame for what occurred. It is indisputable that the loss of life attributed to the sinking of Indianapolis could have been mitigated had the proper individuals in the Navy realized sooner that the ship was overdue. Unfortunately, this was not the case. The United States Navy did, however, learn from this disaster and took immediate steps to ensure that no Sailor or Marine would again face a similar situation. Escort requirements were stiffened, lifesaving equipment improved, and more rigid movement reporting procedures put in place. The story of Indianapolis continues to serve as a point of departure for learning, as evidenced by this volume. Actions of captain and crew of Indianapolis throughout their ordeal, and in the aftermath, stand as exemplars of the highest traditions and honor of the United States Navy. Indianapolis (CA-35) was a decorated World War II warship that is primarily remembered for her worst 15 minutes. Rather than treat these narratives as obstacles to historical inquiry, Igarashi reads them along with counter-narratives that attempted to register the original impact of the war. He traces the tensions between remembering and forgetting by focusing on the body as the central site for Japan's production of the past. This approach leads to fascinating discussions of such diverse topics as the use of the atomic bomb, hygiene policies under the U.S. occupation, the monstrous body of Godzilla, the first Western professional wrestling matches in Japan, the transformation of Tokyo and the athletic body for the 1964 Tokyo Olympics, and the writer Yukio Mishima's dramatic suicide, while providing a fresh critical perspective on the war legacy of Japan.

Fatal Voyage

Despite the limitations of the Washington Naval Treaty, the USS Indianapolis was an imposing warship. It was widely used by US dignitaries in the 1930s, including President Franklin D. Roosevelt, who sailed aboard the ship many times. After the outbreak of World War II, she saw service near Alaska before moving into waters nearer the Japanese home islands. There, she was struck by a kamikaze and forced to return to the US for repairs. Upon completion of the repairs, Indianapolis was selected to transport components of the "Little Boy" atomic bomb from mainland US to Tinian in the Mariana Islands. On the return journey, she was torpedoed and sunk by a Japanese submarine, becoming the last large warship lost by the US during World War II. Delay in the mission to recover surviving crew resulted in the largest loss of life aboard a single ship in US Navy history. The sinking of the Indianapolis remains surrounded in controversy, and the wreck was not located until 2017.

Dictionary of American Naval Fighting Ships

Few ships in American history have had as illustrious a history as the heavy cruiser USS Portland (CA-33), affectionately known by her crew as 'Sweet Pea.' With the destruction of most of the U.S. battleship fleet at Pearl Harbor, cruisers such as Sweet Pea carried the biggest guns the Navy possessed for nearly a year after the start of World War II. Sweet Pea at War describes in harrowing detail how Portland and her sisters protected the precious carriers and held the line against overwhelming Japanese naval strength. Fatal Voyage

This unique book provides a complete account of the tragic sinking of the U.S.S. Indianapolis near the end of World War II. The warship, commanded by Captain Charles McVay, was attacked by a Japanese submarine commanded by Captain Mochitsura Hashimoto. The loss of USS Indianapolis (CA-35) in the first hour of 30 July 1945 left approximately 800 Sailors and Marines out of a crew of 1,196 adrift—most with only a life jacket or floater net. The rapid sinking of the ship, and critical damage to communication systems, prevented the sending of a distress signal. These circumstances, coupled with misunderstandings of protocol for reporting the non-arrivals of ships, delayed the rescue of Indianapolis survivors until 2-3 August. After four to five days spent in the water awaiting rescue, only 316 survived. Many of the casualties resulted from dehydration and overexposure. McVay, III in an attempt to learn more about the tragedy and to make historical records of the sinking more readily available to the Navy community and the public. USS Indianapolis (Ca-35)

Atomic Doctors

Ordeal by Sea, first published in 1963, is the moving account of the World War Two-era cruiser U.S.S. Indianapolis and her crew. On July 30, 1945, after delivering parts for the two atomic bombs dropped on Japan at the U.S. base at Tinian, the ship was torpedoed and sunk by the Japanese submarine I-58. The Indianapolis disappeared beneath the surface of the Pacific in a mere 12 minutes. Of 1,196 crewmen aboard, about 300 went down with the ship. The remaining 900 men faced exposure, dehydration, and shark attacks while floating in the water; there were few lifeboats and almost no food or water. The Navy learned of the sinking when survivors were spotted four days later by the crew of a PV-1 Ventura on routine patrol. Only 317 crewmen would survive in what remains the worst single loss of life at sea in the history of the U.S. Navy. Author Thomas Helm served on the Indianapolis before the war and conducted numerous interviews with surviving crew to prepare the book. The California Gold Rush was in full swing, state of the art steamer ships were used to transport the discovered gold back east, and the Central America was one of them. On its fateful voyage, the ship was carrying nearly 600 passengers and a huge haul of up to 20 tons of gold worth an estimated \$2 million at the time. On the way from Cuba to New York City, the Central America was caught in a Stage 2 hurricane that it never had a chance of knowing about ahead of time. With winds over 100 miles per hour, the hurricane ripped its sails, and the ship started taking on water while struggling to keep its boiler going. These conditions all but doomed the ship, and while over 150 passengers were ferried in lifeboats to another ship for rescue, the intensity of the storm kept the other passengers of the Central America away from salvation. When the ship finally sank, 425 passengers went down with it, and only a handful of survivors were picked up in the ensuing days. The loss of life was a big enough calamity, but the Central America had gone down with so much gold that it scared the American public, which was already beginning to deal with a financial downturn that culminated in the Panic of 1857.
