Group problems are many; why should there be suffering, starvation, and pain? Why should the world as a whole be in the thrall of the direst poverty, of sickness, of discomfort? What is the purpose underlying all that we see around us, and what will be the outcome of world affairs, viewing them as a whole? What is the destiny of the human race, what is its origin, and what is the key to its present condition? It is now difficult to imagine that, in the years before Whitman's death in 1892, there was real doubt in the minds of Whitman and his literary circle whether *Leaves of Grass* would achieve lasting fame. Much of the critical commentary in the first decade after his burial in Camden was as negative as that in Boston's *Christian Register*, which spoke of Whitman as someone who "succeeded in writing a mass of trash without form, rhythm, or vitality."
