IFRS 4 establishes the principles for the recognition, measurement, presentation and disclosure of insurance contracts within the scope of the standard.

The objective of IFRS 4 is to ensure that an entity provides relevant information that faithfully represents insurance contracts. This information gives a basis for users of financial statements to assess the effect that insurance contracts have on the entity's financial position, financial performance and cash flows.

What form can an insurance arrangement take? • The relationship between an insurer and the policyholder is established by a contract. • A 'contract' is an agreement between two or more What is insurance risk? •Insurance risk is a risk, other than financial risk, that is transferred from the policyholder to the issuer of a contract. The issuer accepts a risk from the policyholder that the policyholder was already exposed to. The following table includes examples of insurance risk and financial risk.
